

# Generation update – February 2014

This document was prepared using information available in the public domain; it does not use any material supplied by generators under confidentiality. All information presented is subject to uncertainty and will change as more data comes to light.

The document comprises the following tables:

- Table 1 presents a high level summary of the current generation projects sorted by status, owner, generation type and region;
- Table 2 shows the same list of projects, sorted by earliest possible commissioning date;
- Table 3 lists the details of the projects which are currently under construction, or have received consent, or applied for consent, sorted by generation type; and

Generation projects with capacity less than 5 MW are not shown. Where ranges are provided for capacity, median values are used for statistical purposes.

It should be borne in mind that some types of new projects (particularly thermal peakers) can be consented and constructed relatively rapidly. The projects listed in this document, therefore, should not be seen as an exhaustive list of all generation that could be constructed in the next few years.

Tables 2 and 3 show the projects deemed “consent under appeal” in Table 1. The projects are divided into two groups, those declined resource consent prior to appeal and those approved resource consent prior to appeal.
